Mayor Cagle and city attorney explained that the city owned property (approximately 1 acre) on the North side of McDonald's had mistakenly had a pole barn built on it by the owner of the rest of the property. The city property was originally purchased for water purposes if needed.

A couple of options was discussed, one was taken it to court or the other option was sell him the property. It was brought out that it had several businesses already building on the other property there and it would benefit the city more for sales tax purposes to sell the land.

City Attorney explained that, the city would have to declare the property as surplus before it could be sold. He also said that, a fair market value of \$14,444.00 dollars was arrived at by taking the acreage and what was paid for the adjoining property and dividing the acreage by the dollar amount.

The question was then raised what if the city ever needed it. Attorney Boring explained that a stipulation could be included in the sale if the city ever needed the corner to place a lift station on it that it would be agreeable by the purchaser of the property.

Motion was made by Lansing and seconded by Wheeler to declare the above-mentioned property as surplus.
