A copy of the previous minutes was given to each member of the board and after reviewing; motion to approve as distributed was made by Anderson and seconded by Lansing.

Garrett Angel, Fire Chief informed the board that they had been awarded a Grant for \$26,979 dollars for the purchase of water rescue equipment.

David Decker, Assistant Police Chief, informed the board that they had received \$18,000 dollar Grant that will give them the ability for a subscription and start up fees with Civic Eye for the ability to do electronic reports and citations. He also said that, for the next 4 years it would be \$3,200 per year. This does not include printers or scanners for the cars. However, a grant with Tennessee Highway Safety would be applied for this fall to hopefully cover those cost. He also presented the statue where the city could charge an additional \$5.00 dollars for each citation written that could be used for the system.

City Attorney was advised to look in to adjusting fines and fees on City Citations.

Motion to approve moving \$970.30 of utility debt from active status to inactive status for collection and also approve the utility adjustments was made by Wheeler and seconded by Lansing.
